Water Committee Meeting

Meeting Summary

Chair White introduced himself and staff and asked participants to introduce themselves and their areas of interest. He noted that public input is always welcome. He discussed the goals of the committee, and asked the group to identify the issues they would want the committee to cover, in the following areas: Quantity, Quality, Political and Economic Issues, and Other.

The group then gave their input, which is transcribed on the lists below. Participants then indicated their preferences for issues for the committee to cover. The number of participants that preferred each issue is noted on the list.
