# PROPOSED MOTION\*

---

## **Implementing First Coast Vision and the Strategic Regional Policy Plan: Transportation (Regional Partners: North Florida Transportation Planning Organization and the Regional Transportation Commission)**

- **Regional Community Institute (RCI) will convene interested parties to consider the alignment of a transportation corridor between Jacksonville and Tampa, in advance of statewide analysis of alternatives. The purpose of this work is to ensure that the goals, objectives and policies of First Coast Vision and the Strategic Regional Policy Plan are carried out in this important transportation improvement. Another purpose is to ensure diverse representation in the public and stakeholder engagement that considers a project with the potential for significant impacts on the future of Northeast Florida. When the State focuses on Northeast Florida, RCI will reconvene its group to ensure that the State process benefits from the full diversity of regional participation. If appropriate, RCI will recommend metrics to be tracked by NEFRC as part of its annual State of the Region report. RCI will report results to NEFRC in Fall, 2016.**
